IF I SHOULD DECIDE I DO WANT A LAWYER, AND I CANNOT AFFORD TO HIRE ONE, A LAWYER WILL BE APPOINTED FOR ME FREE OF CHARGE AND I MAY HAVE THAT LAWYER PRESENT BEFORE MAKING ANY STATEMENT.

I ALSO UNDERSTAND THAT I HAVE THE RIGHT TO STOP AT ANY TIME DURING THIS STATEMENT AND REMAIN SILENT AND HAVE A LAWYER PRESENT.

I FULLY UNDERSTAND THESE RIGHTS, AND AT THIS TIME I AGREE TO GIVE UP MY RIGHTS AND MAKE THE FOLLOWING STATEMENT:

Sometime in late February 1992, I went down to Alabama w/WISH for the Mardi Gras. We got a hotel room in some motel off the highway - while I was down there I bought a Glock 7 semi-auto from some Klan guy for \$200. After being down there for about a week and half wish & me went target shooting w/ a guy named Mike & his wife. Mike collects guns and was offering to sell us some a guy was taking who lives in Alabama and

a friend named Rodney Stonberry (Ston) who also lives in Alabama also went target shooting w/us.

The next day (Sunday) we were partying at night & then chillin' in the hotel room until about 200AM when I went to sleep. Before I went to sleep I put my Glock 7 on the desk.

When I woke up in the morning (about 800AM-830AM) Taco was also in the room but WISH was gone. Also missing was my Glock 7.

About 900AM - 930AM WISH appeared in the room w/ a friend of Taco's (I don't know his name but he lives in Alabama), a black guy, w/ WISH showing us two (2) large boxes full of several weapons (guns) including AR-15 rifles and a gatling gun.

When I asked WISH where he got the guns he motioned a cutting gesture w/ his hand over his neck which we all understand as a signal for death.

The next day I found out that Mike's wife got shot in the head. I give this statement to Investigator Michael DeCo of my own free will without any promises or threats made to me.
